Sub:- AHCT-EDM Dept.,- Submission of SCAs by the NWH for the year 2018 & 2019 - Deadlines for submission of the SCA and Imposing Penalty-Certain Guidelines -Intimation -**Reg.**

With reference to the subject cited, it is noticed the some of the Network Hospitals have not submitted the Service Contract Agreement (SCAs) under Aarogyasri and EJHS for the year 2018 and 2019. In this regard, it is to inform that the AHCT has decided a deadline for submission of the SCAs along with fee in the form of DD by the Network Hospitals as mentioned below:

Year	Last date for submission of SCA
2018	31.05.2019
2019	30.06.2019

If the Network Hospitals fails to submit the SCAs in time as mentioned above, “**Stop Payment**” will be initiated,

From next year onwards all SCAs and Renewal fees **should be submitted before 31st March of every year.**

All empanelled Govt. and Private Hospitals should submit separate SCAs for AHS & EHS which are valid up to December of the Calendar Year only irrespective of the month of joining in the scheme.

All empanelled Private Hospitals should submit renewal fee every year Rs.10,000/- only for AHS which is adjusted for EHS also. All Dental Hospitals should submit renewal fee Rs.10,000/- every year

All empanelled Govt. and Private Hospitals are requested to comply before 31st March of every year, otherwise stop payments will be initiated and penalty will be imposed on NWHs (defaulters) as per protocol given below.


Penalty Protocol:

S.No	Period	Action
1	After 31st March	Show cause notice & Stop payment
2	After 30th June	Continue stop payments with penalty of Rs.2000/-
3	After 30th September	Continue stop payments with penalty of Rs.4000/-
4	After 31st December	Continue stop payments payments with penalty of Rs.6000/- & show cause notice to be issued why the NWH cannot be suspended...

All empanelled Hospitals should ensure compliance as instructed in co-ordination with concerned DC & DM

- **Non renewal/Submission of SCA does not exclude NWH from Legal Action as per SCA rules.**
