

22. The Andhra Pradesh Public Health Subordinate Service Rules

[G.O. Ms. No. 3842, Health, Dt. 31-12-1964]

In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor of A.P. hereby makes the following Special Rules for the A.P. Public Health Subordinate Service.

Rule 1. (a) These rules may be called the Special Rules for the A.P. Public Health Subordinate Service and shall be deemed to have come into force on the First day of November, 1956.

(b) For appointment to the posts of Vaccinators, Laboratory Assistants, Field Assistants and Laboratory Attendants (for Agency Areas) preference shall be given to candidates belonging to any of the Aboriginal Tribes specified in Schedule to Part-I of Andhra Pradesh State and Subordinate Services Rules possessing the prescribed qualifications.

(c) Promotion as Assistant Superintendent, Health School, Entomological Assistants, Health Supervisors, and Health Inspectors shall be made on grounds of merit and ability, seniority being considered only where merit and ability are approximately equal.
(Clause 'c' is sub. by G.O. Ms. No. 12, M&H, Dt. 5-1-1982)

(d) The ratio of recruitment between direct recruitment and recruitment by transfer for persons with the required qualification shall be 1:2 : Provided that if a person for recruitment by transfer with the required qualification is not available, the vacancy meant for recruitment by transfer shall also be filled up by direct recruitment.

Rule 3. Appointing Authority :-Vaccinators (for Agency Areas and other Areas) and Health Assistants : District Health Officer concerned.

Laboratory Assistants, Assistant Director of Public Health (Administration) in respect of the staff employed in the Office of the Director of Public Health and the Health Officer, National Malaria Eradication Programme or Health Officer, Class I concerned in respect of the staff in other offices.

Dayas Assistant Director of Public Health (Maternity and Child Health).

Rule 5. Qualifications :- A candidate shall be eligible for promotion by direct recruitment to the post mentioned below if he has not completed the age specified in the corresponding entry thereof.

(b) A person shall be eligible for appointment by direct recruitment to be the post of Entomological Assistant only if he has not completed the age of 32 years.

(c) No person shall be eligible for appointment to the category mentioned in Column (1) of the Annexure unless he possesses the qualifications prescribed in the correspondence entry in Column (2) thereof.

Rule 6. Probation :-Every person appointed to the Service shall from the date on which he/she joins duty be on a probation for a period of two years, on duty within a continuous period of three years if recruited direct and one year on duty within a continuous period of two years, if recruited by transfer and promotion.

Rule 7. Training :-Health Inspectors, Vaccinators and Health Assistants with Sanitary Inspectors qualification who have not completed 50 years of age shall undergo such course of training and pass such examination at the end of the course as may be prescribed by the State Government from time to time. Failure to pass the examination at the end of the course of training shall in the case of those drawing the maximum pay of their time scale of pay entail reduction of pay by one increment which shall continue till they pass the examination and in case of others entail stoppage of increments which shall continue till they pass the examination, but shall not have the effect of postponing future increments. Health Inspectors and Vaccinators with Sanitary Inspector qualification who have completed 50 years of age will have the option to undergo the training or not. They need not sit for the examination mentioned in this rule.

Rule 8. Private Practices :-Health Inspectors (including Selection Grade Health Inspectors), Vaccinators, Health Assistants, Health Visitors & Midwives shall not engage in private practice.

Rule 9. Postings and Transfers :-{a) Postings and transfers of Health Inspectors from one range to another within a District shall be made by the District Health Officers or Health Officer concerned.

(b) Postings and transfers of Vaccinators from one range to another in the Agency Areas, Midwives and Dayas within a District shall be made by the District Health Officer concerned and from Agency Areas in a district to Agency Areas in another District shall be made by the Director of Public Health.

(c) Transfer of Laboratory and Field Assistant from jurisdiction of one Health Officer (or Health Officer N.M.E.P.) to another shall be made by the Director of Public Health.

(d) Transfer of Midwives and Dayas from one District to another shall be made by the Director of Public Health.

Rule 10. Repeal :-The rules in force in both Andhra and Telangana Areas before the commencement of these integrated rules are hereby repealed.

Rule 11. Nothing contained in these rules shall adversely affect the persons already promoted as Entomological Assistants, in terms of Government Memo. No.867/IIIIn8-II, Medical and Health, dated 2nd January, 1979, and continuing as such on the date of issue of this notification.

4. Health Supervisors :-Promotion from among Auxiliary Health Workers and Block Extension Educators. (G.O.Ms.No.534, Health, Dt. 5-7-1973; G.O.Ms.No.439, Dt.21-4-1977 and G.O.Ms.No.546, M. & Health (H-1), Dt.13-7-1982)

5. Health Inspectors:-(i) A Sanitary Inspector's Certificate granted by the Director of Public Health (A.P.), as the Chairman of the Board of Examiners constituted in this behalf by the State Government (including certificate granted by the Public Health Institute, Hyderabad) ; or

B.Sc. (Public Health) Degree of any University in India established or incorporated by or under a Central Act, Provincial Act or State Act or an institution recognised by the University Grants commission. (G.O.Ms.No.1609, Health, Dt.23-9-1971)

(ii) Ability to read and write at least one of the languages mentioned here :- Telugu, Hindi, Urdu, Oriya, annada, Tamil or Marathi.

(iii) Physical fitness for camp life.

6. Vaccinators :-Direct recruitment- qualification prescribed above for Health Inspectors.

Note :-The existing incumbents in the posts of Grade II Vaccinators should pass the Sanitary Inspectors Course within 3 years from 1-1-1957 failing which they will not be allowed to draw more than two increments in the scale of Rs.S0-3-80.

7. Health Assistants :-*Direct recruitment* — qualification prescribed for Health Inspectors.

8 & 9. Laboratory Assistants and Field Assistants:--(i) Laboratory Assistants must possess a completed S.S.L.C. or Matriculation and Field Assistants must have passed III form or a pass in Middle School Examination ;

(ii) Must have a good physique, good vision, capacity for outdoor work ; and

(iii) Must have undergone the preliminary training for a period of not less than one month in the case of Field Assistants and 3 months in the case of Laboratory Assistants in one or more of the Malaria Field Stations.

10. Laboratory Attendants :--(a) Must have passed III Form or a pass in Middle School Examination in a recognised School maintained by or opened with sanction of the State Government or to which recognition has been accorded by the Director of Public Instructions, Andhra Pradesh under the Andhra Pradesh Educational Rules, or

(b) (i) Must have passed the Indian Air Force Educational Test for reclassification to leading Air Craftsman : Provided that preference will be given to persons possessing the educational qualification mentioned in case (a); and

(ii) Must have a good physique, good vision and capacity for outdoor work.

11. Draughtsman :--(1) A certificate granted by the College of Engineering, Guindy on the completion of the course prescribed for the Lower Subordinate Class; or

(2) A certificate granted by the Government School of Engineering, Visakhapatnam or in any recognised Government School in the erstwhile Hyderabad State;

(3) A certificate obtained after a course of study in the School of Engineering, Burma; or

(4) A pass in the examination prescribed for the Engineering Subordinate or the Overseer Class or the Sub-overseer Class or the Draughtsman Class in the College of Engineering, Guindy; or any recognised College in Andhra Pradesh or a pass in the Special Examination for group certificate in Building and Drawing which has been prescribed for Draughtsman in Government Technical Examination; or

(5) A Certificate of Proficiency issued by the Director General, Resettlement and Employment (Government of India, Ministry of Labour) under the Technical Training Scheme for having passed Grade II Proficiency Test in the Grade of Draughtsman (Mechanical).

12. Artist and Photographer :--(1) A pass in the advanced grade in Government Technical Examination in free hand outline and Model Drawing and Painting or the Diploma of the Government School of Arts and Crafts, Madras or any other recognised School in Andhra Pradesh in those subjects; and (1) A certificate of proficiency in Photography granted by a reputed Photographic Firm under whom he has worked for a period of not less than two years.

13. Librarian :--(1) B.A. or B.Com degree of a University recognised by University Grants Commission, and (2) A diploma in Library Science.

14. Propaganda Technician :--(1) Working knowledge of English; (2) Capacity to read out description of magic lantern slides or making brief announcements to the public in one of the regional languages; (3) Possession of a certificate of competency from any recognised firm or institution of Radio Engineers; and (4) Possession of a certificate or proficiency in operating a cinema projector granted by cinema house.

Direct recruitment :--(1) A candidate must not have completed 35 years of age on the first day of July of the year of recruitment;

(2) Must possess Health Visitor's Diploma granted by the Government of Hyderabad or any other qualification recognised as equivalent to it by the Government of Andhra Pradesh.

*By promotion :--*Must have passed the Health Visitor's Training Course or its equivalent (G.O. Ms. No.1084, M&H Dt. 23-11-1980).

16. Midwives :--Trainees from the recognised Government Institutions in the State will be appointed directly by the Director of Public Health on completion of their training. If no such candidate is available the posts will be filled by direct recruitment by the Director of Public Health.

16.A. Auxiliary Nurse Midwives :--Must be a holder of Auxiliary Nurse Midwife Certificate from a recognised institution in the State.
