ORDER:-

The Government in their G.O.Rt.No. 4433, General Administration (Services-A) Department, dated 04-12-1986 requested the One Man Commission to comprehensively examine, revise and up date the Service rules for the Gazetted posts in Government Examinations. The One Man commission submitted its report on revision of rules relating to the Gazetted posts in Government Examinations.

(2) The Government, after due consideration accept the report of One Man Commission with slight modifications and issue the following rules.

(3) The following Notification will be published in the Andhra Pradesh Gazette:-

NOTIFICATION

In exercise of the powers conferred by the Proviso to article 309 of the Constitution of India, the Governor of Andhra Pradesh hereby makes the following special rules for the Andhra Pradesh Government Examinations Service.

Rules:

(1) Short Title and Commencement:

These rules may be called the Andhra Pradesh Government Examination Service Rules, 2001.

(2) Constitution:

The Service shall consist of the following categories of posts in the Andhra Pradesh Government Examinations Service.

| Category | --- | Designation |
|----------|-----|---|
| (1) | --- | Director of Government Examinations. |
| (2) | --- | Deputy Commissioner for Government Examinations. |
| (3) | --- | Assistant Commissioner for Government Examinations including Secretary to Commissioner for Government Examinations. |

(3) Method of appointment and appointing authority:

Subject to the other provisions in these rules, the method of appointment and appointing authority for the several categories shall be as follows:-

| Category (1) | Method of appointment (2) | Appointing authority (3) |
|--|--|-------------------------------------|
| 1 Director of Government Examinations | By Transfer of Additional Director in Class-I-A of A.P.E.S. | Government |
| 2 Deputy Commissioner for Government Examinations | By promotion from Category ó 3 i.e., Assistant Commissioner for Government Examinations | Director of Government Examinations |
| 3 Assistant Commissioner for Government Examinations | By appointment by transfer of Superintendent in the Andhra Pradesh Ministerial Service in the Government Examinations Department | Director of Government Examinations |

(4) Qualification:-

- No person shall be eligible for appointment as Deputy Commissioner for Government Examinations unless he holds a Graduate Degree of any University in India.
- No person shall be eligible for appointment by transfer as Assistant Commissioner for Government Examinations unless he is a graduate of a university in India, established or incorporated by or under a Central Act or State Act or a Provincial Act or an institution recognised by the University Grants Commission.
- One must pass the Accounts Test for Executive Officers or Account Test for Subordinate Officers Part-I for appointment by Transfer / Promotion to the post of Assistant Commissioner for Government Examinations.

(5) Probation:-

Every person appointed by promotion or by transfer to any post in the Service shall, from the date on which he joins duty, be on probation, for a total period of one year on duty with in a continuous period of two years.

(6) Minimum Service:-

No member of the service shall be eligible for promotion or appointment by transfer to the next higher category of post, unless he is an approved probationer and has put in not less than three years of service in the category from which such promotion or appointment by transfer is made.
